Use of Information Technology by Nurse Theorists (M. Sandelowski)

OVERVIEW

Nursing and technology have been inexorably linked since the beginnings of trained nursing in the United States in the late nineteenth century. Whether or not they thought of the devices they used as technology, nurses have necessarily used a variety of tools, instruments, and machines--from thermometers to cardiac monitors--to appraise, treat, and comfort patients. Tracing the relationship between nursing and technology from the 1870s to the present, Margarete Sandelowski argued that technology has helped to shape and intensify persistent dilemmas in nursing and that it has both advanced and impeded the development of the profession.



In her book <u>Devices and Desires: Gender, Technology, and</u>
<u>American Nursing</u> Sandelowski examined key moments in the

history of nursing that dramatize the ironies of the nursing-technology relationship. She demonstrated that nurses both embraced and rejected technology in their pursuit of cultural visibility and professional autonomy--with varying amounts of success.

Technology is not only used by nurses in practice or education, but by nurse theorists themselves. "With global travel, telecommunications, information technology, and the Internet, the boundaries of space, time, geography, and language have greatly diminished the barriers that nurse theorists faced in the twentieth century. Today, because of current technology, it is possible for almost any student to ask a major theorist a question about a theory and receive an answer without ever leaving his or her living room. Nurses who have an interest in nursing theory now have the opportunity to connect with colleagues internationally with similar interests that they would otherwise have never met and learn from participation in online communities." (Sitzman. & Wright Eichelberger, 2011, p. 209 - 210).
